# Acceptance of payment orders to KB via internet banking and in very exceptional cases at a branch during the last days of the year 2024

Dear Customer.

in connection with the approaching end of the year 2024 we would like to inform you about changes related to the acceptance of payment orders and execution of cash deposits at the branches of Komerční banka, a.s., during the last days of this year.

The standard method of submitting payment orders is via electronic banking channels. For exceptional cases, all the branches will be open during the standard opening hours on the business days at the end of the year 2024 with exception of 31 December 2024, when the opening hours will be shortened to 1 pm without a lunch break, except for the branch Olomouc – Šantovka, which will be closed at 12 pm.

# DOMESTIC PAYMENT TRANSACTIONS

Komerční banka will accept domestic payment orders until 31 December 2024 inclusive in a standard way. Payment orders can be delivered to branch counter in Komerční banka on Tuesday, 31 December 2024, except for the branch Olomouc – Šantovka, which will be closed at 12 pm. Acceptance of non-cash payment orders at counters can only be used in emergency cases, for a fee of CZK 100, which is listed in the KB Price List.

## **INTERNET BANKING**

In case of submission of payment orders via KB internet banking (MultiCash KB, Expresní linka KB, MojeBanka, MojeBanka Business, Profibanka, Přímý kanál, Mobilní banka, Mobilní banka Business, KB+), also follow the above deadlines for the submission of orders at the branch desk with the exception of the hour (cut-off time), which is set by the conditions agreed for the given system.

Dates and actual cut-off times for MojeBanka, MojeBanka Business, Profibanka, Mobilní banka, Mobilní banka Business and KB+ are listed in the notice boards of these applications and KB web site.

## **CASH PAYMENT ORDERS**

Cash deposits to accounts kept at Komerční banka, a.s., and realized at cash desks on 31st December 2024 will be cleared with this value date.

Cash deposits to accounts kept at another banks operating in the Czech Republic made at KB branches on the day of the cash deposit will be cleared to the CNB to payee's payment account in the CERTIS payment system.

Deadlines for acceptance of the transaction and subsequent transfer in the CNB payment system to the payee's bank:

- Cash deposit at the KB counter by 2.30 pm will be cleared to the CNB payment system account on the same business day;
- Cash deposit at the KB counter after 2.30 pm will be cleared the following business day to the CNB payment account.

Cash deposits submitted by clients via closed packages in accordance with the Universal contract about handing over of cash via closed packages (packages via night vault until 8 a.m., another packages until end of opening hours of branch), on 31st December 2024 remain unchanged, i.e. they will be credited in favor of the beneficiary's account with Komerční banka on 31st December 2024.

Payment orders delivered and process cash deposits after these terms will be processed in KB, but the orders might be delivered according to payment type to other bank in the year 2024.



# FOREIGN PAYMENT TRANSACTIONS

Komerční banka will accept foreign payment orders until 31 December 2024 inclusive. If you have to settle your obligations vis-à-vis your foreign partners until the end of the year 2024 (with value date 2024), you should transmit your foreign payment orders according to the deadlines set below at the latest.

Credit of funds to beneficiary's account depends on the beneficiary's bank processing terms.

Payment orders received in later terms will be processed by the bank with the value date of the year 2025.

## INTERNET BANKING

In case of submission of payment orders via KB internet banking (MultiCash KB, Expresní linka KB, MojeBanka, MojeBanka Business, Profibanka, Přímý kanál, Mobilní banka, Mobilní banka Business, KB+), also follow the above deadlines for the submission of orders at the branch desk with the exception of the hour (cut-off time), which is set by the conditions agreed for the given system.
