Acceptance of payment orders via internet banking and Expresní linka KB during the last days of the year 2024

Dear Customer,

in connection with the approaching end of the year 2024 we would like to inform you about changes related to the acceptance of payment orders via MojeBanka, MojeBanka Business, Profibanka, Přímý kanál, Mobilní banka, Mobilní banka Business and Expresní linka KB during the last days of this year.

The valid deadlines for sending payments are those dates stated in the Notice on the Payment System, for direct banking services in section D and for Expresní linka KB in section E. The following information only specifies these deadlines for specific dates at the end of the year 2024 according to the type of payment submitted to Komerční banka in terms of KB internet banking.

DOMESTIC PAYMENT TRANSACTIONS

Komerční banka will accept domestic payment orders until 31 December 2024 inclusive. If you want to be sure that your interbank payment orders will be cleared in both banks in the year 2024, you should submit orders to Komerční banka on the dates set below.

Overview of the latest terms for payment orders for domestic payments, which shall ensure clearing still in 2024.

1) Method of submission:

Batch - batch payment processing mode (payment in CZK with conversion and Express payments will be processed in online payment processing mode), continuous processing mode - first attempt of processing is online. Online - individually delivered orders, orders in batch with online processing mode.

2) CERTIS – Payment settlement system in Czech national bank (CNB) – The meaning for payment order is setllement on the creditors bank account and for direct debit it is sending the direct debit to CNB.

3) Online outgoing payment orders routed to other banks between 12 pm and 2.15 pm in batch and between 1 pm and 2.15 pm as individual payments can be sent to the CERTIS the same day (without guarantee). Payment orders delivered after 2.15 pm will be sent to the CERTIS in the year 2025.



Payment orders delivered after terms defined in table above will be processed only in Komercni banka, these payment orders can be sent to other bank (according to payment type) in year 2025.

The deadlines for making payments to other banks are subject to valid legal regulations. However, KB does not accept responsibility for the value date that the other bank applies to the beneficiary's account.

For payments in foreign currency to the accounts kept with another banks in the Czech Republic, please use the Foreign payment order according to the overview below.

This year you can use Instant Payments (Instant Incoming Payments and Instant Outgoing Payments) between the banks that have joined the Instant Payment scheme. You will receive this information in the MojeBanka, MojeBanka Business, Mobilní banka and Mobilní banka Business, direct banking services, where you can enter Instant Outgoing Payments. For operational reasons, the execution of Instant Payments will be limited at the turn of the year, so that it will not be possible to receive or send Instant Payments between 31 December 2024 16:00 hrs and 1 January 2025 8:00 hrs.

Instant Payments are being received on a 24/7 basis and influence the available balance within a few seconds. Instant Incoming Payments and Instant Outgoing Payments received and recorded in accounts held with KB by 16:00 hrs on 31 December 2024 will be reflected in the balance shown in the KB account statement as at 31 December 2024.



FOREIGN PAYMENT TRANSACTIONS

Komerční banka will accept foreign payment orders until 31 December 2024 inclusive. If you have to settle your obligations vis-à-vis your foreign partners until the end of the year 2024 (with value date 2024), you should transmit your payment orders according to the deadlines set below at the latest having a due date that will be the same as the date of submission to KB.

Credit of funds to beneficiary's account depends on the beneficiary's bank processing terms.

Payment orders received in later terms will be processed by the bank with the value date of the year 2025.
